The Trustees of the IBEW Local No. 9 and Line Clearance Contractors Health & Welfare Fund (the Fund) are providing you with this notice to explain important improvements to your benefits.

Dental and Orthodontia Benefit Improvements

Effective January 1, 2026, the Calendar Year Maximum Dental Benefit is increased from \$1,500 to \$2,000 and the Calendar Year Orthodontia Maximum Benefit is increased from \$2,500 to \$3,000. The dental and orthodontic benefits are provided for you and your eligible dependents. The Calendar Year Maximum Dental Benefit does not apply to covered individuals younger than age 18. Dental benefits are administered by Delta Dental of Illinois. You can contact Delta Dental by calling (800) 323-1743 or visiting www.deltadentalil.com. All other Dental benefits remain unchanged. Notice of Grandfathered Health Plan Status. The IBEW Local No. 9 and Line Clearance Contractors Health & Welfare Fund believes its entire plan of benefits, including the retiree option provided therein, is a "grandfathered health plan" under the Patient Protection and Affordable Care Act (the "Affordable Care Act"). As permitted by the Affordable Care Act, a grandfathered health plan can preserve certain basic health coverage that was already in effect when that law was enacted. Being a grandfathered health plan means that the Plan may not include certain consumer protections of the Affordable Care Act that apply to other plans, for example, the requirement for the provision of preventive health services without any cost sharing. However, grandfathered health plans must comply with certain other consumer protections in the Affordable Care Act, for example, the elimination of lifetime limits on benefits, once those consumer protections become effective for the plan. Questions regarding which protections apply and which protections do not apply to a grandfathered health plan and what might cause a plan to change from grandfathered health plan status can be directed to the plan administrator at (877) 423-9155.
